



STIPEND AND PAYROLL FUNDING FOR PHD STUDENTS 2024-2025

All students accepted to the doctoral program, including international students, who continue to make appropriate academic progress receive four years of fellowship support. As of the 2024-2025 academic year, this consists of an annual stipend of \$42,745. A fifth year of fellowship funding is available to students after they successfully defend their dissertation proposal. We also provide full tuition, personal health insurance for all five years, and travel and research reimbursement of up to \$1,700 per year.

Please note that the Annenberg School may alter any of the described benefits going forward, but admitted students would remain eligible for the support that was in place at the time of their admission to the school.

STIPENDS

Students in years 1-4 receive Research or Teaching Fellow stipends as outlined below. Students who have begun their Dissertation Research Fellowship receive a 12-month stipend. All Fellowship stipend amounts are gross (pre-tax) and may be adjusted due to inflation.

TWO-FOUR	Research Fellowship (RF) Research Fellow Service Stipend Teaching Fellowship (TF) Teaching Fellow Service Stipend	\$42,745	Paid in equal monthly installments of \$3,562.08 over 12 months from September 2024 through August 2025.
FIVE	Dissertation Research Fellowship (DRF) Educational Fellowship Non-Service Stipend	\$42,745	Paid in equal monthly installments of \$3,562.08 over 12 months according to the student's approved DRF application .
